### **CYBER THREATS**

Definition – any malicious software or attack attempt to damage a system

**Human error - phishing** 

Unauthorized access – click malicious link or open infectious file

Unauthorized users misusing data – change, remove or misuse data without proper approval or authorization

### **CYBER THREATS**

"Cyber threats are no longer a matter of if, think when"


Data breaches and leaks – sensitive information such as personally identifiable information

Loss or corruption of data – back up not working

Digital threat actors or adversarial threats

### **Scams**

- Wire scams
  - Pressured to act urgently



- Asked to open an account or deposit a check and then wire some or all of the money to someone you do not know
- Mostly interacted with the recipient via email
- Your recipient's wire instructions or info changes at the last minute
- Check fraud
  - Intercept check
  - Create digital check using routing and account number



# **Audit, Review or Compilation**

- Zonta International Bylaws
  - District
    - Examine financial records (audited, reviewed or compiled by certified/chartered public accountant or a qualified individual independent of the district board)
  - Club
    - Examine financial records by a person independent of the board
- Check district or club bylaws

  - Dues
